woodsman, fighter and scout. He will relate trials, tribulations and hardships, especially with the Indians, in the years just before Solomon Wertman's migration to Ashland County. The first settlers arrived in Ashland County in 1808. The town of Ashland was laid out in 1815. In 1817, there were four cabins. As late as 1820, there was Indian trouble in the area. Settlers continued to come, mainly from New York, Connecticut, and Pennsylvania (Germans). By 1830 when Solomon arrived, the population of Ashland had increased to 235.

### **Picnic and Business Meeting**

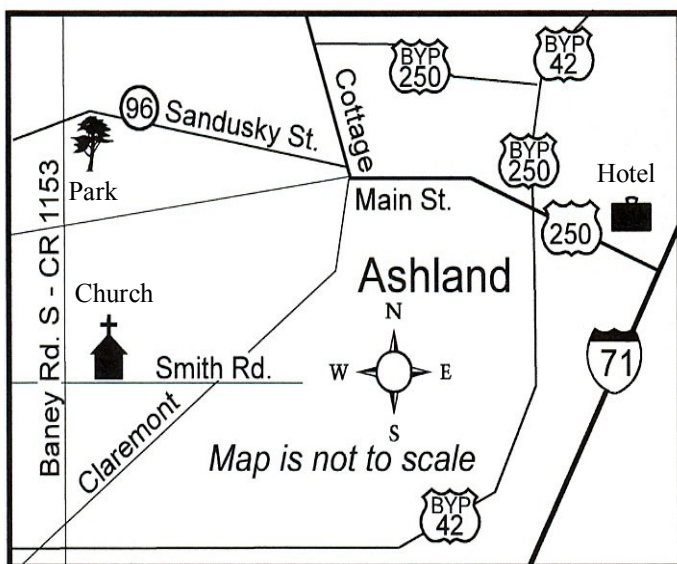

## **WFA Reunion, August 2007 Lehigh County, PA**

### **Minutes, Researchers Meeting**

President Russell Dannecker opened the Wertman Family Association's researchers' meeting at 10:00 a.m. on August 17, 2007, with a welcome to all. There were 31 in attendance.

Russ explained why the meeting was being held at the Ontelaunee Rod and Gun Club. This is the area where the first known home was of our mutual ancestor, George Philip Wertman I. The cabin was within a few yards of the building in which we were having our meeting. He then told how, after a great deal of very astute sleuthing, he was able to determine the probable, exact site of the original dwelling. This involved such things as eliminating the bottom of a pond as the location of foundation stones. The thought that we were virtually on the spot of our mutual beginnings in America over 250 years ago was awesome!

Tom Young presented an update on our web exposure and some of the problems obtaining domain names and web sites. This area continues to be a work in progress. The key seems to be, *keep it simple*. We will probably limit the information to the first four generations of the GP1 family. "Google Books" and *footnote.com* were mentioned as helpful genealogical sites.

Richard Daniels followed with information on six known Wertman sons who migrated to Illinois. This group produced an astonishing number of descendants. Handouts were available for browsing.

Tom Young briefly discussed the Sorenson DNA project. So far we have only one Wertman participant, however 20 kits were available at the meeting, so we hope to have more results next year.

Russ Dannecker related a coincidental tale of the Daniel Z. Wertman family of Lower Sandusky, OH. On a whim, he located the graves; a short time later, the wife of Daniel Z.'s great-grandson inquired if he had any information on their branch of the family!

Participants enjoyed lunch at a nearby restaurant. The food was good and very efficiently served.

The afternoon started with Russ Dannecker relating the rest of the story of the colorful Civil War veteran, Ruben Wertman. With the help of records in

the library in Medina, OH, Russ found that Ruben was buried in Homerville Cemetery, Medina Co. He was able to locate the grave and assure that proper veterans' recognition would be placed there.

Shirley Daniels, the next presenter, reviewed a most attention-grabbing time-line of world events that might have influenced the lives of our ancestors.

Russ Dannecker talked about Wertmans in Michigan. He spent several weeks there this year with the intention of documenting Wertmans there. His first discovery was that this task couldn't be completed in the time he had available. He concentrated on the family of Emanuel B. Wertman, who moved to Otsego Co. in the northern part of the state. He will need to return at a later date to untangle various other Michigan families.

Russ followed with an explanation of Geogen, a web site that creates maps showing the concentration of family names in various areas of Germany and Austria. After trying numerous spelling variations of the name Wertman with little success, he found a number of people named Werthmann and Wortman in the state of Bavaria, and concentrated in the picturesque little village of Wertheim. He showed some pictures of it and murmurs went through the group that it might be a great place for a future reunion!

The meeting ended with Tom Young updating information on George Philip I's grandchildren. There is still some questionable or unproven information that he will continue to pursue.

On Friday evening, a delicious Pennsylvania Dutch dinner was served at the New Tripoli Fire Company. Richard Miller gave a most interesting presentation of Pennsylvania German customs and local history after the meal.

### ***Minutes, Business Meeting***

President Russell Dannecker called to order the Wertman Family Association business meeting on August 18, 2007, after the family picnic held at Ontelaunee Park. He welcomed the largest attendance since 2000 and presented the following special awards: Melanie Skrocarski, from Atlanta, who came the farthest, received a flashlight timepiece; the most senior lady award, a cut glass music box, went to Mary Alice McLaughlin, who

arrived on this earth in 1911; the most senior gentleman, Herb Dannecker, who was born in 1927, received a gold tie tack; and Megan June Feil, nine weeks old, received a pop-up book.

Ed Wertman moved to accept the minutes from 2006 as printed in the newsletter.

Treasurer Shirley Wertman reported \$6,745.80 in the treasury, before paying expenses for the reunion and adding profits from the auction. Donations received for the monument totaled \$3,900. Jan Dannecker moved to accept the treasurer's report.

The Reunion Committee gave their report and thanked everyone for their participation.

## The “Reading 11” of Lynn Township 1777: More of the Story

Our German ancestors’ resolve was tested more than we know. Wertmans were more involved in Colonial military conflict due to several factors; undoubtedly there is more in histories and records. The Pennsylvania Archives, Series 2, Volume XIV, pages 625-627, gives a picture of the 1777 arrest of eleven men in Northampton County, Pa. This was no small family matter; it extended to the Wyoming Valley. We begin with excerpts giving testimony from some of the people involved.

“At a Meeting of the Standing Committee, held at Easton, the 15th day of February, 1777, present, Peter Kohler, Arthur Lattemore, Jacob Shoemaker, Timothy Reed, Jeremiah Trexler. Abraham Berlin, Peter Myer & Peter Beisel.

“On Motion Peter Kohler was chosen Chairman *Pro Tem*.

“*The State of Pennsylvania vs. William Thomas & others.*

“For certain treasonable practices committed by them against the said State, as well in signing certain papers to the prejudice of the American Cause, as in their Conversation, &c....”

The “certain papers” referred are a mutual self-defense agreement signed among some 80 residents of the Lynn Twp. area. (For the text of the agreement and another view of the matter, see “Bad Tories,” by Richard Hull, published posthumously in *Wertman Lines*, June 2002.)

“Peter Gift says that Jacob Oswald read the papers to him and that he heard Philip Moser say if they signed that paper they might stay at home & not go with the Militia, for the Militia were going to draft & if any of the Signers should be fetched by the Militia they would defend themselves & Assist one another ag’st them.

“Andrew Miller says, that he heard Philip Moser say that there was a Proclamation given out that they should have peace again, as in the year 1763, if they laid down their

Arms, and whoever sign’d that paper might have peace. That William Thomas & his two Brothers & Samuel Custard were present at the Meeting held at Burghart Moser’s in Lynn Township.”

From the book *Sweet Land of Liberty*, we learn that some Moravian residents of the area lost their property just because they refused to commit to either side of the conflict, being neutral as a religious conviction. Burghardt Mosser, at whose home there was a meeting about the pact, may have been a Captain in the Militia. This needs more research.

“Frederick Sander says, that the intent of Signing that paper was that whoever signed it might stay at home, & not go to the Camp with the Militia.

“Jacob Oswald says, that William Thomas came to his house on the evening of the 15th December last, Jacob Wertman being in Company with him; W. Thomas asked this examinant to go along with him to Philip Moser’s, & that he should take pen & ink with him; accordingly they went together to said Moser’s; in the meantime Wertman went and gave Notice to Daniel Oswald & others to attend to said Moser’s also; when they came to Philip Moser’s, Wm. Thomas said to said Jacob he should draw a piece of Writing which they would sign in Order to defend themselves against the Wyoming People and others who had threatened to come and destroy their property; which the s’d Jacob Oswald at first refused to do, but however, afterwards consented and the s’d Wm. Thomas & Philip Moser told him what to write word for word.”

Another reason presented to sign the paper was a threat of harm from people who were involved in the Wyoming massacre, the site of repeated, armed conflict between settlers from Connecticut and Pennsylvania natives (later, Tories and Indians). Some Northampton County people were deeply involved in the Wyoming conflict, and some had been sent to Wyoming to police the situation, for which they received land grants in Northampton County (source, Harvey’s *History of Wilkes-Barre, Pa.*, annotated by Louis Ogden, family researcher; Hal Merz’s ancestors). The mention of these events alone would be enough to convince some people to

sign the defense pact. To learn more of the fragile condition of those times, read the letters in Series 2, Volume XIV, leading up to the dates recorded here.

“Thomas dictated more than Moser; said Oswald took only a Minute of the Writing that Evening in Order to Write it next day; Wm. Thomas & Philip Moser gave Notice to those present to attend at Burghart Moser's, next day by 10 O'Clock in the forenoon, in Order to Sign the said paper; Next day Jacob Oswald went to Burghart Moser's & wrote the paper which is the same now shewn to him by the Committee—Wm. Thomas told him to put a penalty in the same which he did of Fifty pounds.”

William Thomas was a wealthy landholder of Northampton County plots amounting to more than 1,000 acres. He actually became the leader of the Bucks County Volunteers, the Loyalist regiment in which George Phillip Wertman II participated.

“*Same Meeting:*

“Colo. Geiger says, that when William Thomas was a prisoner at the house of Michael Shnyder about the 24th Decem'r last, the said Thomas said to the Colonel, I am a prisoner now, but Lord Howe will be over the Delaware in a short time and then you will be a prisoner.

“Philip Moser says, that it was strongly reported that some of the Militia under Colo. Geiger and some from Wyoming would come and take away all their clothing, and for that reason they had made the Writings in order to defend themselves; that Philip Anthony had been up at Wyoming and had told the people there that he the said Moser was a great Tory and that they should come down and destroy his Effects. ”

William Thomas' Loyalist sentiments threatened the very person (the arresting Col. Geiger) who had control of his destiny at that point. Phillip Anthony was another Lynn Township neighbor, whose land bordered Ebenezer Church. Philip Moser and GPI were neighbors and founders of Ebenezer Church.

“Upon hearing the several Evidences in the above Cause, and the confession of the parties themselves, it appears that they are severally guilty of the charge laid against them; for which they were committed;

therefore, *Resolved*, That each of them Sign a Parole drawn up by the Council of Safety of this State; that they give Sufficient Security for their future good behavior in the respective Sums, to their Names hereunder set, which Security to be a Freeholder and Associator; that each of them pay the sum of Money to his respective Name annexed, being the Costs accrued thereupon, and that each Man pay his Gaolers:

“The said 15th Fbry 1777.

“Michael Buck, Casper Baldauf, Henry Stininger, Jacob Oswald, Martin Stuck, Taken before Peter Kohler, Chairman, Cond'd that they & each of them be of future good behavior towards the State of Pennsylvania, each sent in all respects, especially in £100 during the present dispute between the Colonies and Great Britain. Whereupon they signed the Parole and paid Costs.”

It appears these five men were actually present at the council meeting, and that they were only fined 100 pounds, which they paid in person.

“At a Meeting of the Standing committee held at Easton the 20th day of February, 1777, present, Abraham Berlin, Peter Kohler, Arthur Lattemore, Peter Beisel, Jacob Shoemaker, Timothy Reed, Anthony Moor & Jeremiah Trexler.

Why were Haller and Burghart Moser's names mentioned twice with two different amounts?

Why did Jacob Wertman send in £400? His fine was not the heaviest as with William Thomas and Phillip Mosser.

“Taken in Committee Cond'd, that they the said Michael, Philip, William, Daniel, Peter & Jacob, & each of them be of future good behavior towards the State of Pennsylvania and the other United Colonies during the present dispute between the said Colonies and Great Britain. Whereupon they severally signed the Parole and paid Costs.”

Evidently Jacob Wertman and several others did not come to the February 20 meeting, but sent in their fines to the committee.

### *Some points for further research*

Henry Oswald went to the British. Is he the same Oswald listed in the General Muster Roll June 18th 1777 with Philip Wertman ?

Daniel Oswald is in the first class General Muster Roll June 18th 1777. Is he the same one listed above as paying a fine?

### *Author's notes:*

Most of the information in the preceding article came from the Pennsylvania Archives, Series 2, Vol. XIV. We are unsure if this is the same series that Richard Hull used, but some of the information we came across is different.

Have many of you tried the following? Google Wertman “Pennsylvania Archives”. Try various spellings including Wertman and Vortman. Happy hunting. - Hal
